### **Information for Authors**

**Author Responsibilities:** WIT Press distributes its publications throughout the world and wants to ensure that the material submitted to its publications is properly available to the readership of those publications. Authors must warrant that the work is the author's original work and has not been published before (if excerpts from copyrighted works, figures, diagrams, photos, trademarks or other such materials are included, the author will obtain written permission from the copyright owners and show credit to the sources in the manuscript.) The author also warrants that the paper describes genuine research or review work, contains no libelous or unlawful statements and does not infringe on the rights of others.

**Author/Employer Rights:** If you are employed and prepared the Work on a subject within the scope of your employment, the copyright in the Work belongs to your employer as a work-for-hire. In that case, WIT Press assumes that when you sign this Form, you are authorised to do so by your employer and that your employer has consented to the transfer of copyright, to the representation and warranty of publication rights, and to all other terms and conditions of this Form. If such authorization and consent has not been given to you, an authorised representative of your employer should sign this Form as the Author.
